

RESOLUTION NO. 99-137

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DESIGNATING THE SIDEWALKS ADJACENT TO GALT OCEAN DRIVE AS AREAS WHERE SIGNS MAY BE POSTED PROHIBITING BICYCLING.

WHEREAS, Galt Ocean Drive is located along the beach north of Oakland Park Boulevard, and begins and ends at State Road 1A; and


WHEREAS, persons bicycling on the sidewalks of Galt Ocean Drive pose a hazard to the numerous residents and visitors traversing the sidewalks; and

WHEREAS, pursuant to Section 26-182(a) of the City's Code of Ordinances, the City Commission desires to designate the sidewalks along Galt Ocean Drive as areas where signs may be posted prohibiting bicycling;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:


SECTION 1. That pursuant to Section 26-182(a) of the City's Code of Ordinances, the sidewalks along Galt Ocean Drive are designated as areas where signs may be posted prohibiting bicycling.



SUBJECT: October 5, 1999 Agenda – Galt Ocean Mile Area – Prohibition of Cyclists on Sidewalks - Installation of "No Bicycles on Sidewalk" Signs

Prior to the renovation of the Galt Ocean Mile that began in 1994, there were "No Bicycles on Sidewalk" signs posted along the sidewalk in the area. During the renovation the signs were removed and were not reinstalled after the project was completed. The area residents are now requesting that a limited number of the signs be reinstalled.

Pursuant to Section 26-182 of the City Code of Ordinances, areas where bicycles are prohibited must be designated by resolution of the City Commission. We have determined that the population density, limited walking area on the Galt Mile, the age of some of the area residents, and the existence of marked shoulders within the roadway, provide appropriate justification to prohibit bicycles on the sidewalk in this area.

We recommend the Commission adopt a resolution prohibiting cyclists on the sidewalks in the immediate area of and adjacent to Galt Ocean Drive and authorize the installation of "No Bicycles on Sidewalk" signs at appropriate locations.
