RESOLUTION NO. 2015-44

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA, AUTHORIZING THE TOWN MANAGER TO EXECUTE AN AGREEMENT WITH THE FORT LAUDERDALE TRANSPORTATION MANAGEMENT ASSOCIATION, INC TO EXTEND THE SUN TROLLEY GALT LINK SERVICE NORTH TO WASHINGTONIA AVE FOR AN ANNUAL SUM NOT TO EXCEED \$25,000; PROVIDING FOR AN EFFECTIVE DATE.

15 **WHEREAS**, the mission of the Downtown Fort Lauderdale Transportation
16 Management Association (TMA) is to provide convenient, accessible, and reliable
17 transportation in the advancement of economic vitality, a clean environment, and support
18 of our community; and

19 **WHEREAS**, the TMA operates the Sun Trolley Galt Link service every Monday,
20 Tuesday, Wednesday, Friday, and Saturday from 8:30am to 4:30pm, providing
21 transportation for Galt Mile residents to shopping, entertainment, and public service; and

22 **WHEREAS**, the TMA and the Town of Lauderdale-By-The-Sea (“Town”) both
23 desire to extend the Sun Trolley Galt Link across municipal boundaries north to
24 Washingtonia Avenue; and

25 **WHEREAS**, extending the Sun Trolley Galt Link into the Town would increase
26 the points of connection with Town’s Pelican Hopper service and increase the transit
27 options for residents and visitors in both municipalities; and

28 **WHEREAS**, an extension of the Sun Trolley Galt Link would reduce the number
of cars on the road and the demand for public parking in the Town; and

29 **WHEREAS**, extending the Sun Trolley Galt Link would more readily connect to
30 restaurant and shopping establishments in both municipalities and thus increase the
31 opportunity for economic development; and

32 **WHEREAS**, the Town desires to negotiate a one year contract for the TMA to
33 provide such extended service, with opportunities for one year extensions if approved by
34 the Town Manager and for 90 day termination for convenience.

35 **NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION**
36 **OF THE TOWN OF LAUDERDALE-BY-THE-SEA:**

37 **SECTION 1:** The foregoing recitals contained in the preamble to this Resolution
38 are incorporated by reference herein.

39 **SECTION 2: Authorization of Agreement.** The Town Manager is hereby
40 authorized to negotiate and execute an agreement between Fort Lauderdale
41 Transportation Management Association, Inc. and the Town of Lauderdale-By-The-Sea
42 to extend the Sun Trolley Galt Link service north to Washingtonia Avenue for one year,
43 with an option for the Town Manager to extend the service for additional years, and with
44 a 90-day termination for convenience clause.

45 **SECTION 3: Authorization of Funds.** The Town is hereby authorized to expend
46 funds not to exceed \$25,000 for the provision of extended Sun Trolley Galt Link service
47 in FY 16, and \$25,000 for each additional year of extended service that the Town
48 Manager may authorize.

49 **SECTION 4:** This Resolution shall take effect upon its adoption.


